

Privacy Notice

The data protection principles, relating to data processing of the service on the oriolusprogram.org website, is continuously available at the linked website.

Versavica Kft. and the Oriolus Program operated by it, hereinafter referred to as the Data Controller, acknowledges the content of this statement as binding but reserves the right to change the statement with public notification in due time. The Data Controller attaches the utmost importance to respecting the rights of its clients to informational self-determination. The Data Controller handles the personal information confidentially and takes all measures to ensure the security of data.

Principles of data processing:

Personal data can be processed if

- (a) the affected person agrees (voluntary), or
- b) it is ordered by the law or local government decree for a purpose of public interest (obligatory).

Personal data may be transmitted and various data management processes may be linked if the data subject has consented or permitted by law and the conditions of data processing for each personal data are met.

Personal data may only be processed for a specific purpose, to exercise a specific right and to fulfill an obligation.

Only personal data that is necessary and suitable for the purpose of data processing and only to the extent and for the time necessary for the purpose may be processed. Voluntary personal data may only be processed with the informed consent.

The data subject shall be informed in a clear, comprehensible and comprehensive manner of all facts relating to the processing of data, in particular the purpose and legal basis of the data processing, the data subject and the duration of data processing. The information should also cover the rights and remedy options of data subject.

It is forbidden to use a generic and uniform ID that can be used without restriction.

Personal data processed

- (a) be recruited and treated fairly and lawfully;
- (b) accurate, complete and, where necessary, kept up to date;
- (c) the manner of storage must be such that the data subject can be identified only for the time necessary to achieve the purposes for which they are stored.

The transfer of data to the EEA States shall be considered as a transfer within the territory of Hungary. Personal data may be transferred to a data controller or data processor in a third country subject to the explicit consent of data subject or permitted by law and an adequate level of protection of personal data is ensured in the processing of the transferred data in the third country.

The scope of personal data

Data processing is based on voluntary consent.

Please note that data providers are required to obtain the consent of data subject if they do not

provide their personal data.

Scope of processed data: Applicant's family name, first name, e-mail address, telephone number, age, nationality, country/region of residence) and, in the case of participants under 16, the surname, first name, e-mail of the participant's parent/guardian. (This information will only be used by our company for the purpose of the participant's program registration and contacting his/her parent.)

Deadline for deletion of data: 10 years from the date of last login and until the withdrawal of consent to receiving newsletters. Accounting documents are retained for 8 years pursuant to Section 169 (2) of Act C of 2000 on Accounting.

What are cookies and how do we handle them?

Cookies are small data files ("cookies") which are sent to your computer by the usage of and through the website and stored by your internet browser. Most commonly used web browsers (Chrome, Firefox, etc.) accept and allow the download and use of cookies by default, but it is up to you to refuse or disable cookies by changing your browser settings or already stored cookies on your computer can be deleted. For more information on the use of cookies see the "Help" menu item in each browser.

Versavica Kft. and the Oriolus Program operated by it will inform you about Cookies which require consent and ask for your consent at the beginning of the first visit if data processing begins already by visiting this site.

Versavica Kft. and its operated Oriolus program do not use and do not permit the use of cookies which may collect data for third parties without your consent.

Cookies are not subject to acceptance, however Versavica Kft. and the Oriolus Program operated by it are not responsible for the fact that the website may not function as expected without the permission of cookies.

Client correspondence and partner inquiries of Versavica Kft. and the Oriolus Program operated by it:

You can contact our secretariat by phone or e-mail in case of any questions or problems while using our services. The Data Controller will delete the incoming mails including the sender's name and e-mail address and any other voluntarily provided personal information within five years of the matter being settled.

Other data processing

Data processing not mentioned in this brochure will be provided at the time of recording of data.

The way of storing personal data, security of data processing

Data processing related to website visit:

Versavica Kft. and the Oriolus Program operated by it do not require the submission of

personal information in order to view the information published on oriolusprogram.org website.

Versavica Kft. and the Oriolus Program operated by it automatically receive the following information about the visitors of the website: IP address of the visitor, time of visit, sub-pages and contents viewed on the website.

This data is displayed in Google Analytics due to automatic data transmission. This data is used by Versavica Kft. and the Oriolus Program operated by it solely for the purpose of analyzing the website and checking its secure operation.

Data processing related to the applications made on the website and the personal data of minors.

Versavica Kft. and the Oriolus Program operated by it use the data provided in applications for events published on the website and during institutional admission pre-registration/registration to send additional information about the given events, to manage the personal data of minors based on parental consent, to reach parents/guardians, maintain contacts and to create invoices.

The way of storing personal data, security of data processing

The computer systems and other data storage locations of the website are located at the Data Controller's headquarters and online space.

Versavica Kft. and the Oriolus Program operated by it select and operate the IT tools used to manage personal data in the provision of its services in such a way that the processed data:

- (a) is accessible for those who are entitled (availability);
- (b) its authenticity and authentication are assured (authenticity of data processing);
- (c) its unchangeability is provable (data integrity);
- (d) is protected against unauthorized access (confidentiality of data).

Versavica Kft. and the Oriolus Program operated by it take technical and organizational measures to protect the security of data processing that provide a level of protection appropriate to the risks associated with data processing.

Versavica Kft. and the Oriolus Program operated by it, during data processing, retain

- (a) confidentiality: protect the information so that only authorized persons have access to it;
- (b) integrity: protect the accuracy and completeness of information and the method of processing;
- (c) availability: ensure that when an authorized user needs it, he/she can actually have an access to the information and tools that he/she needs.

The IT system and network of Versavica Kft. and the Oriolus Program operated by it are equally protected against computer fraud, espionage, sabotage, vandalism, fire and flood, as well as computer viruses, computer hacking and 'denial of service' attacks. The operator maintains security through server-level and application-level security procedures.

We inform the users that electronic messages transmitted over the Internet, regardless of the protocol (e-mail, web, ftp, etc.), are vulnerable to network threats which lead to fraudulent activity, contract disputes or disclosure and modification of information. The service provider takes every precautionary measures that may be required in order to protect against such threats. The systems are monitored to record any security inconsistencies and provide evidence for each security incident. System monitoring also makes possible to check the effectiveness of the applied precautionary measures.

Legal remedy options

The data subject may request information about the processing of the personal data and also may request the rectification or deletion of personal data, except as provided by law, in a way indicated at the data collection. The data controller, at the request of the data subject, shall provide information on the controlled data or on behalf of the data processor on the processed data on the purpose, legal basis, duration, name and address (seat) of the data processor and to whom and for what purpose receive or have received the data.

The data controller shall provide the information in writing in a clear format in the shortest time up to 30 days from the submission of the request. This information providing shall be free of charge in case of the person requesting the information has not yet submitted a request for information to the data controller concerning the same area in the current year. In other cases Versavica Kft. and the Oriolus Program operated by it will charge a fee.

Versavica Kft. and the Oriolus Program operated by it delete personal data if its processing is unlawful, the data subject requests it, the purpose of data processing has ceased, the statutory time limit for data storage has expired or it is ordered by the law court or the National Data Protection and Freedom of Information Authority. Versavica Kft. and the Oriolus Program operated by it shall inform the data subject on the rectification and deletion of data as well as all persons to whom the data have previously been transmitted for data processing purposes. Notification shall be omitted if does not harm the legitimate interest of the data subject with regard to the purposes of data processing.

The data subject may object to the processing of their personal data if

(a) personal data must be processed (transmitted) solely for the purpose of enforcing the rights or legitimate interests of data controller or recipient of data, unless such processing is

required by law;

(b) the usage or transmission of personal data is for the purpose of direct marketing, opinion polling or scientific research;

c) exercising the right of protest is otherwise permitted by law.

Versavica Kft. and the Oriolus Program operated by it shall investigate the objection within the shortest period, up to 15 days from the submission of the application, with the immediate suspension of data processing and inform the applicant in writing of the result thereof. If the protest is justified the data controller shall terminate the data processing including further data collection and transfer, block the data, inform everybody to whom the data have previously been transmitted and is obliged to take action to enforce the right of protest.

The data subject may initiate a law court procedure if he/she does not agree with the decision of the data controller within 30 days of being informed.

Versavica Kft. and the Oriolus Program operated by it may not delete the data of the affected person if the data processing has been ordered by law. However, the data may not be forwarded to the recipient if the data controller has agreed to the protest or the law court has declared the protest as justified.

The data subject may take a legal action against the data controller in case of violation of rights. The law court will deal with the matter in an expedited procedure.

Versavica Kft. and its own operated Oriolus Program indemnify for damages caused to others by unauthorized processing of the data or violation of technical data protection requirements. The data controller is not responsible for damages caused by an unavoidable reason out of the scope of data processing.

The data controller does not compensate for the damage to the extent that it was the result of intentional or grossly negligent behavior of the injured party.
